# EVERGREEN FALL MINI EVENT

Raindate – Sunday, September 25<sup>th</sup>, 2005

Here's your chance to close off the season with a fun day of Eventing with Mike Gallagher.

This is a fun learning event that allows riders & horses to participate in the 3 phases of eventing – Dressage, Stadium Jumping and a Cross-Country Course. You have the choice of participating in all 3 phases or may choose 1 or 2 phases only. Please note that one horse may be ridden by multiple riders in various phases, but each rider/horse combination requires a separate entry .

## **DIVISIONS OFFERED: ENTRY, STARTER, PRE-TRAINING**

**DRESSAGE:** Training Level Test 1 (the 2003 Equine Canada (Dressage Canada) Test (Test will be in 20 x 40 sand ring)

**STADIUM:** Approximately 8 – 10 fences

**CROSS COUNTRY:** Approximately 10 jumps, no ditches, no banks, no time, and the course can be cantered or trotted.

## **How high are the jumps?**

Entry Level: Cross Rails /Logs -max 18”

Starter Level: Jumps -max 2’ to 2’6

Pre-Training: Jumps – max 3’

**Prizes:** Ribbons to 5<sup>th</sup> place & Prizes

## **General Rules and Regulations:**

Stabling is not available, however we will schedule to accommodate the traveling of out of town entries. Show will commence with Dressage Tests @ approximately 9:00 am.

Proof of Vaccine: Competitors are required to show proof of Flu and Rhinos at the time of entry or arrival.

Entries must be completed in full, with all signatures, and payment in full.

All competitors must wear approved protective headgear, at all times, when mounted.

Riders & owners must be members of NBEA.

The show organizers, sponsors, or property owner do not accept any responsibility for accidents or illness to horses, riders, grooms, spectators, or any other person – see “Declaration for Participant”.

The judge's decision is final in all classes. The Judge reserves the right to excuse any unmanageable or lame horse or any rider abusing the horse.

Refunds: Test fees (80%) excluding administration fee will be refunded upon presentation of a veterinarian's certificate. Documentation must be received within 4 days of event. Any Cancellations/scratches after September 22<sup>nd</sup> are non-refundable.
