I/we hereby acknowledge that there is liability coverage in force with respect to the ownership of the competing horse. I/we hereby acknowledge that the "sport of horses" is a high risk sport, which risks may include injury (or death) to both horse and rider, through normal use, schooling and competition. I/we hereby accept the inherent risk of equestrian sports, and acknowledge that I/we are participating at my/our own risk and in full knowledge of the hazards and potential hazards which are inherent in this sport and competition. It is hereby recognized that no helmet or protective equipment can protect against all foreseeable injury. In consideration of being allowed to participate in this event, I/we hereby assume all risk and I/we hereby release and absolve the EVERGREEN RIDING CENTER, National, Provincial and Discipline Affiliates, the Organizing Committee, volunteers, judges, course designers, officials, directors, agents, representatives and employees, and the owners and occupiers of the land upon which the competition is held, from all responsibility, liability or claims of any nature and kind which I/we may have arising from my/our participation in this activity, including but not limited to bodily injury or death to myself or my/our horse(s) and damage to property arising from any cause whatever, including the negligence of one or more of the individuals and organizations referred to herein.
